



Camper Health & Safety Policy *May 26, 2020 (subject to change)*

Required Documents

Each child must have a health history form and emergency consent form on file prior to the start of your camp week. These will not be available in paper form. Please complete and upload onto CampSite prior to the start of your child's week of camp.

What to Bring

Two snacks and a lunch. Items should be clearly labeled in disposable containers. Bottled water is required – water fountains will not be available for use. Water, Gatorade and pre-packaged snacks are available for purchase. All charges will be made to your CampSite account and charged accordingly.

Swimming

Campers will swim one time per day between 10:00am and 12:00pm. Campers should arrive at camp with swimsuit on if possible.

Sunscreen

Parents are responsible for applying sunscreen to children prior to camp drop off. Please provide spray only sunscreen in your child's bag for application in the afternoon. Hats are recommended for those concerned about sun exposure.

Lockers

When arriving to camp, campers will be assigned a labeled locker or cubby for their belongings throughout the week. Campers will not be permitted to carry personal items with them throughout the camp day. This includes cell phones.

Daily Activities

Children will be divided into mixed age groups (5 to 8 and 9 to 11) of 10 campers to one counselor. Campers will spend the day with the same group and same designated counselor when feasible. Children will spend time outdoors and indoors while maintaining social distancing from other groups. When possible, specialty camps will run as scheduled. Any changes to your camp will be made at least one week prior to the start of the camp week. Please note that changing camps/groups throughout the week will not be permitted. Groups will not be combined, this includes in hallways and bathrooms. Children will be required to wash hands frequently throughout the day. CDC and state guidelines will be followed at all times. Counselors

Parents will be notified of their child's counselor prior to the start of their child's week of camp. All counselors will complete a daily COVID-19 screening, including temperature checks. A counselor presenting a temperature of over 100.4 degrees Fahrenheit will be considered not safe to attend camp. (Continued)

Counselors will carry sanitization supplies with them throughout the day. Supervisors and housekeeping teams will also be available to assist with all sanitization guidelines. Team members will wear masks at all times.

Drop off/Pick Up Procedures

All children will be picked up and dropped off from the Adventure Central entrance. Parents may not enter the building. Curbside drop off and pick up will be available.

Drop off

A COVID-19 screening, including a temperature check, hand sanitizer and/or hand washing using mobile handwashing stations will be performed. Campers presenting a temperature of over 100.4 degrees Fahrenheit will be considered not safe to attend camp. Once cleared for check in, children will be taken to the appropriate group by **acac** team members.

Pick up

When arriving, parents will call the number posted. An **acac** team member will bring the camper to the parent for ID check and check out.

Communication

Parents are encouraged to communicate all questions through phone at 610-341-7000 or email at wc-summercamp@acac.com. A team member will monitor between 7:00am - 6:30pm daily.

Team **acac** will continue to monitor the implications of COVID-19 and its impact on our community. We will stay in close contact with the CDC, and state and local officials and make changes to our processes and policy as the guidelines warrant.
